WINASAP5010 v1.09 includes the following corrections and enhancements:

- Resolve the “B” in loop 2033 CLM10 in the CLM segment that is causing issues upon save that was inherited from 4010 to 5010. The problem occurs when 4010 data from Winasap2003 is transferred to Winasap5010 by using the DB Convert tool. “B” should no longer be found in 5010 but was inherited upon db conversion. This problem is reported thru JIRA 7779.
- Resolved issues to Other Diagnosis Codes in which the second ICD defaults to ICD10 upon save. The problem occurs when the user clicks on the other diagnostics code and set it to ICD9 in the Professional Claim data. Upon save when the other diagnostics code is clicked again the second ICD defaults to ICD10. The problem is reported thru JIRA 7815.
